RE: NOTIFICATION OF COPYRIGHT INFRINGEMENT
(Pursuant to 17 U.S.C. § 512)

To whom it may concern:

I represent Bandai Namco Music Live Inc., a Japanese corporation (hereinafter called “BNML”), the representative of the author of the copyrighted works identified under the column entitled “Original Work” in Exhibit A attached to this notice (“Exhibit A”).

It has recently come to BNML’s attention that certain users of your services have unlawfully published and posted certain contents on the website located at <https://hikarinoakari.com/>, <https://hnadownloads.co/>, more specifically identified under the column entitled “Infringing Work” in Exhibit A (referred to as the “Infringing Work”), corresponding to each of the Original Work identified in Exhibit A.

BNML has a good faith belief that the Infringing Work is not authorized by the copyright owner, its agent, or the law.

We demand that you immediately disable access to the Infringing Work and cease any use, reproduction, and distribution of the Original Work. Specifically, we request that you remove or disable the Infringing Work from <https://hikarinoakari.com/>, <https://hnadownloads.co/>,

or any of your system or services.

We also request a written assurance that you have fully complied with our request.

I declare that the information in this notice is accurate, and under penalty of perjury, that BNML and I are authorized to act on behalf of the owner of the exclusive right of the Original Work that is infringed.
